#### **SUMMARY OF KEY POINTS**

**What personal information do we process?** When you visit, use, or navigate our Services, we may process personal information depending on how you interact with us and the Services, the choices you make, and the products and features you use.

**Do we process any sensitive personal information?** We do not collect or process sensitive personal information such as your racial or ethnic origins, sexual orientation, or religious beliefs.

**Do we collect any information from third parties?** Our station is hosted on Live365.com. We may collect information about your location, listening devices, and listening durations from this third party.

**How do we process your information?** We process your information to provide, improve, and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also process your information for other purposes with your consent. We process your information only when we have a valid legal reason to do so.

**In what situations and with which parties do we share personal information?** We may share information in specific situations and with specific third parties.

**What are your rights?** Depending on where you are located geographically, the applicable privacy law may mean you have certain rights regarding your personal information.

### 1. WHAT INFORMATION DO WE COLLECT?

#### Personal information you disclose to us.

We collect personal information that you voluntarily provide to us when you express an interest in obtaining information about us or our projects and Services, when you participate in activities on the Services, or otherwise when you contact us.

**Personal information provided by You.** The personal information that we collect depends on the context of your interactions with us and the Services, the choices you make, and the products and features you use. The personal information we collect may include the following:

- Names
- Contact preferences
- Phone numbers
- Email addresses

**Sensitive information.** We do not process sensitive information.

**Application Data.** If you use our application(s), we may also collect the following information:

- Geolocation Information. Our third party will share with us location based information from your mobile
  device, either continuously or while you are using our mobile and website applications, to provide certain
  location-based services. If you wish to change our access or permissions, you may do so in your device's
  settings.
- Push Notifications. We may request to send you push notifications regarding your account or certain features of the application or events in our Services. If you wish to opt out from receiving these types of communications, you may turn them off in your device's settings or email <a href="mailto:zfunhundred@gmaill.com">zfunhundred@gmaill.com</a> to request removal.

**Information Automatically Collected.** We automatically collect certain information when you visit, use, or navigate the Services. This information does not reveal your specific identity (like your name or contact information) but may include device and usage information, such as your IP address, browser, and device characteristics operating systems, language preferences, referring URLs, device name, country, location, information about how and when you use our Services, and other technical information. This information is primarily needed to maintain the security and operation of our Services, and for our internal analytics and reporting purposes.

The information we collect includes:

- Log and Usage Data. Log and Usage Date is service-based, diagnostic, usage, and performance information our third party servers collect when you access or use our Services and which we record in our log files. Depending on how you interact with us, this log data may include your IP address, device information, browser type, and setting information about your activity in the Services (such as the date and time stamps associated with your usage, pages, and files viewed, searches, and other actions you take such as which features you use), devise event information (such as system activity, error reports, and hardware settings).
- Location Data. We collect location data such as information about your device's location, which can be either precise or imprecise. How much information we collect depends on the type and settings of the device you use to access the Services. For example, we may use GPS and other technologies to collect geolocation data that tells us your current location (based on your IP address). You can opt out of allowing us to collect this information either by refusing access to the information or by disabling your Location setting on your device. However, if you choose to opt out, you may not be able to use certain aspects of the Services.

#### 2. HOW DO WE PROCESS YOUR INFORMATION?

We process your personal information for a variety of reasons, depending on how you interact with our Services, including:

- **To respond to user inquiries / offer support to users.** We may process your information to respond to your inquiries and solve any potential issues you might have with the requested service.
- **To request feedback.** We may process your information when necessary to request feedback and ot contact you about your use of our Services.

#### 3. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?

#### 4. WHAT IS OUR STANCE ON THIRD-PARTY WEBSITES?

The Services may link to third-party websites, online services, or mobile applications and / or certain advertisements from third parties that are not affiliated with us and which may link to other websites, services, or applications. Accordingly, we do not make any guarantee regarding any such third parties, and we will not be liable for any loss or damage caused by the use of third-party websites, services, or applications. We cannot guarantee the safety and privacy of data you provide to any third-party websites. Any data collected by third parties is not covered by this Privacy Notice. #### 5. HOW LONG DO WE KEEP YOUR INFORMATION?

We will only keep your personal information for as long as it is necessary for the purposes set out in this Privacy Notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements.)

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize such information, or, if this is not possible (for example, because your personal information has been stored in back up archives), then we will securely store your personal information and isolate it from any further processing until deletion is possible.

#### 6. DO WE COLLECT INFORMATION FROM MINORS?

We do not knowingly collect, solicit data from, or market to children under 18 years of age, nor do we knowingly sell such personal information. By using the Services, you represent that you are at least 18 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of the Services. If we learn that personal information from users less than 18 years of age has been collected, we will deactivate the account and take reasonable measures to promptly delete such data from our records. #### 7. WHAT ARE YOUR PRIVACY RIGHTS?

**Withdrawing your consent.** If we are relying on your consent to process your personal information, which may be express and / or implied consent depending on the applicable lwa, you have the right to withdraw your consent at any time. ## 9. DO UNITED STATES RESIDENTS HAVE SPECIFIC PRIVACY RIGHTS?

**Categories of Personal Information We Collect.** In the last 12 months, Z Fun Hundred has not collected any personal information in the following categories:

- Personal Information as defined in the California Customer Records statute.
- Protected classification characteristics under state and federal law.
- Commercial information such as financial details or payment information.
- Biometric information.
- Internet or similar network activity.
- Audio, electronic, sensory, or similar information.

- Professional or employment-related information.
- Education information.
- Inferences drawn from collected personal information.
- Sensitive personal information.

We have not disclosed, sold, or shared any personal information to third parties for a business or commercial purpose in the preceding twelve months. We will not sell or share personal information in the future belonging to website visitors, users, and other consumers.

We may have collected other personal information outside these categories through instances where you interacted with in person, online, or by phone or mail in the context of:

- Receiving help through customer support channels.
- Participation in customer surveys or contests.
- Facilitation in the delivery of our Services and to respond to your inquiries.

We will use and retain the collected personal information as needed to provide the Services for 1 year.

#### YOUR RIGHTS

You have rights under certain US state data protection laws. However, these rights are not absolute, and in certain cases, we may decline your request as permitted by law. These rights include:

**Right to know** whether or not we are processing your personal data.

**Right to access** your personal data.

**Right to correct** inaccuracies in your personal data.

**Right to request** the deletion of your personal data.

**Right to non-discrimination** for exercising your rights.

**Right to opt out of** the processing of your personal data if is used for targeted advertising (or sharing as defined under California law), the sale of personal data, or profiling in furtherance of decisions that produce legal or similarly significant effects.

Depending upon the state where you live, you may also have the following rights:

Right to access the categories of personal data being processed. (including the privacy law in Minnesota).

Right to obtain a list of the categories of third parties to which we have disclosed personal data (including privacy law in California, Delaware, and Maryland).

Right to obtain a list of specific third parties to which we have disclosed personal data (including privacy law in Minnesota and Oregon).

Right to obtain a list of specific third parties to which we have sold data (including privacy law in connecticut).

Right to review, understand, question, and depending on where you live, correct how personal data has been profiled (including privacy law in Connecticut and Minnesota).

Right to limit use and disclosure of sensitive personal data (including privacy law in California).

Right to opt out of the collection of sensitive data and personal data collected thru the operation of a voice or facial recognition feature (including privacy law in Florida).

#### **HOW TO EXERCISE YOUR RIGHTS**

Under certain US state data protection laws, you can designate an authorized agent to make a request on your behalf. We may deny a request from an authorized agent that does not submit proof that they have been validly authorized to act on your behalf in accordance with applicable laws.

## REQUEST VERIFICATION

Upon receiving your request, we will need to verify your identity to determine you are the same person about whom we have the information in our system. We will only use personal information provided in your request to verify your identity or authority to make the request. However, if we cannot verify your identity from the information already maintained by us, we may request that you provide additional information for the purposed of verifying your identity and for security or fraud-prevention purposes.

## **APPEALS**

Under certain US state data protection laws, if we decline to take action regarding your request, you may appeal our decision by emailing us at <a href="mailto:response">response</a> to the appeal, including a written explanation of the reasons for the decisions. If you appeal is denied, you may submit your complaint to your state attorney general.

## **CALIFORNIA "SHINE THE LIGHT" LAW**

California Civil Code Section 1798.83, also known as the "Shine the Light" law, permits our users who are California residents to request and obtain from us, once a year and free of charge, information about categories of personal information (if any) we disclosed to third parties for direct marketing purposes and the names and addresses of all third parties with which we shared personal information in the immediately preceding calendar year.

## 10. DO WE MAKE UPDATES TO THIS NOTICE?

We may update this Privacy Notice from time to time. The updated version will be indicated by an updated "Revised" date at the top of this Privacy Notice. If we make material changes to this Privacy Notice, we may notify you by prominently posting a notice of such changes. We encourage you to review this Privacy Notice frequently to be informed of how we are protecting your information.
